Broadband Expansion: CTN provides the platform for rural and urban, large and small health care systems and providers to become part of the CTN with access to secure high speed broadband along with a variety of other services.

FCC Rural Health Care Pilot Program: Over 800 rural and underserved sites are eligible for no cost installation and reduced fees for medical grade broadband.

CTN Model Communities: Fifteen communities with multiple telehealth sites are developing new and innovative programs under the CTN Model Communities Project.
