DISCUSSION: The attendees discussed the continuation of the consortium and how to strategically best move forward. The consortium agreed to remain a four member county consortium and restructure the member County work plans to focus significantly on legislative issues, both at the state and federal level. As broadband issues become more and more relevant in state and federal legislature, the consortium realized it is pertinent to remain together and leverage the reputability of a 4 county consortium where each Member County represents varying topography and demographics.

DISCUSSION: Calvin Sandeen from Sonoma County and Peter Pratt from Marin County gave an overview of the comments NBNCBC submitted to the USDA on the e-Connectivity Program. They emphasized the importance of submitting comments so that California is included as a beneficiary of the new pilot program and is also recognized as a state having many agricultural/rural areas in need of broadband funding. They later went into more detail on specific comments submitted in response to initial comments requested by the USDA. The group continued to discuss joining the Public Knowledge Coalition to assist NBNCBC and its regions needs in being more effectively represented in future federal broadband programs and legislation.

DISCUSSION: Each County gave an update on broadband related progress each has been making.

<u>Marin County</u> is working on broadband infrastructure projects in Bolinas and Nicasio. Nicasio is 85% complete, and there are 320 poles under study in Bolinas. Lastly, there is an adoption project to bring affordable services to low income communities and students in the Canal area.

<u>Mendocino County</u> is working with providers to serve additional communities in Mendocino County – working west side of Willits, Laytonville, and Brooktrails. There have been staff and organizational changes being dealt with. Broadband Alliance of Mendocino County has replaced Trish steel with their new director, Kathy Wylie.

Napa County had two updates. First, they are expanding broadband to three farmworker houses with Mifi at each center. Second, Napa County is contracting work with Magellan Advisors to assess 1.)

Telecommunications damage, 2.) Areas of resiliency and improvement, 3.) Recommendations on funding.

<u>Sonoma County</u> is working on its Broadband Strategic Plan, contracted with Magellan Advisors. The BSP is nearing completion, receiving final guidance from County departments before presenting to the Board of Supervisors. In addition, Sonoma County is applying for a Design and Engineering study from the Economic Development Administrations Disaster Recovery grant to deploy broadband infrastructure in Dry Creek Valley.
