#### **Broadband Update**

- January 11, 2017 The NBNCBC sponsored a "Legislative Day in Sacramento" in which we
  met with 6 representatives (Senators Doddd, Wiener, McGuire and Assembymembers AguiarCurry, Wood, and Levine) to discuss the Internet For All Now legislation. This is upcoming
  legislation to bring back the CASF state broadband program; unfortunately, there have been
  concessions made in order to get votes needed for passage, which greatly weakens the
  potential good of the bill. There has been a fair amount of discussion on this between
  consortia members, within the county, and with legislators. As proposed, without changes, we
  can't support this legislation.
- January 19th, 2017 There was a celebration of PUC Commissioner Sandoval's 6 years of service on the PUC held in San Francisco. She has been a great support for our county, and so I attended to show our appreciation. She specifically thanked Mendocino County in her speech, and said that she was thinking of our county when she pulled her "3 all-nighters" (her husband piped up and said "more than 3") when she wrote the 180 page proposed decision. This decision of course was approved by the full PUC in their December meeting.
- So I guess I should bring this up now as well the carriers were not happy with the Proposed Decision. On January 27th they submitted a letter to the CPUC requesting a 6-month delay for the implementation of the requirements of the Decision. Mendocino county responded by signing onto the formal response comments of TURN asking the PUC to deny the carrier's request. You can find Mendocino County's letter here.
- I plan to start getting endorsements for the Broadband Goals and Strategies that the Broadband Working Group developed. Please watch for an email about this, asking for the endorsement of the Alliance to this document.
- There are new USDA grant funding programs available, and on 1/26/17 I shared information
  with the carriers. (removed) was interested and responded back, and asked about areas that
  need service. I provided information with him about our priority areas, and made introductions
  for him as well and said that I'm ready to support and work with him on projects. I do not know
  how the current administration policies may impact these federal grant programs, but I would
  guess they will be impacted in a negative way.
- Congressman Huffman is also introducing a new federal broadband funding bill the <u>New Deal</u> <u>Rural Broadband Act.</u>

  Vicki Terbovich from the Sonoma Count Library will be attending, along with Dave
  Smith our IT guy from MCOE. I have invited the County Librarian Karen Horner as
  well, but she has not yet confirmed whether she will attend. There have been some
  changes to E-rate and we hope to learn more about potential leveraging of these
  programs.
- The next meeting of the NBNCBC Oversight Committee meeting will be on Thursday, February 16th, 3:00 (call in meeting, using our usual conference number with) I will be gone during this time, so please contact Dan Hamburg for details of the meeting if you want to join.
- I will be traveling from Feb 8 Feb 19, and out of email contact.

### **Broadband Deployments**

- Anchor Bay Campground (between Gualala and Point Arena) was successful in getting better service to the 39 residents of their campground. They shared their success story with me, and I have <u>posted it on our website</u>, and encourage you to take a look.
- The provider for the campground, SkyFiber, is also deploying new services to some businesses in Gualala.
- I connected the "cyber wholesaler" who provided bandwidth to SkyFiber with a potential provider who wants to deploy new services in an underserved area. I can't share any details at this time however.
- US Cellular is upgrading their Cellular coverage in Covelo; I spent time with one of their techs going through the provisions and standards of the new streamlined permitting process, which they will probably use for the upgrade.
- AT&T is moving ahead with the CAF2 project areas. The Alliance organized a meeting between AT&T and county planners to discuss issues they have identified with their sites. I thought it was a very productive meeting.

• Unfortunately, the EPA planning grant that the City of Willits applied for was not selected. This was a disappointment as we really thought that we had a great proposal, and we had strong letters of support as well. I have asked the grant administrator if they can tell us why we were not selected, but I have not yet heard back from him yet.
